- Bank Proposals – (Jay was unable to attend; Guy reviewed the info. Jay provided) Jay Wenger, hired as the Borough Financial Advisor, sent requests for proposals to 8 local financial institutes. Two banks responded. Jay recommends the ACNB proposal option #1; a maximum borrowing of up to \$650,000, 25 year term, 5 year fixed rate of interest of 2.66%, years 6 thru 25 range of interest from 2.75% up to a maximum of 4.65%. Guy also recommends Council accept this proposal.
