The Borough of Abbottstown is a political subdivision of the Commonwealth of Pennsylvania; and

Under the authority of section 601 of the Pennsylvania Municipalities Planning Code (MPC), 53 P.S. §10601, Abbottstown has enacted a Zoning Ordinance (Ordinance) to implement its comprehensive plan and to accomplish the purposes of the MPC; and

Under section 1404 of the Ordinance, Abbottstown Borough Council shall, by resolution, create a schedule of fees to be paid to defray the cost of administering and processing applications for zoning and related applications; and

Among other matters, the fees cover the costs of the zoning officer for reviewing applications and related matters and for purposes of determining compliance with the Ordinance; and

The appointed zoning officer for Abbottstown, PA Municipal Code Alliance, has established a schedule of fees for 2024 (Fee Schedule) for professional fees and out-of-pocket costs; and

The Fee Schedule (attached hereto as Exhibit A) is reasonable for services provided to Abbottstown Borough in connection with the Ordinance;

NOW, THEREFORE, BE IT RESOLVED, that the Fee Schedule is hereby approved for purposes of zoning and related matters levied by Abbottstown against applicants for zoning review and related services.
