A RESOLUTION OF THE BOROUGH OF ABBOTTSTOWN, ADAMS COUNTY, PENNSYLVANIA, AUTHORIZING THE ENTRY INTO AN INTERMUNICIPAL AGREEMENT WITH BERWICK TOWNSHIP

WHEREAS the Pennsylvania Intergovernmental Cooperation Act, 53 Pa. C.S. §2301-§2317 (the "Act"), provides that two or more local governments in the Commonwealth may jointly cooperate in the exercise or in the performance of their respective governmental functions, powers or responsibilities; and

WHEREAS pursuant to the Act, local governments so cooperating are authorized to enter into any joint agreements as may be deemed appropriate for those purposes; and

WHEREAS pursuant to the Act, the governing bodies may only enter into a intergovernmental cooperation agreement upon the passage of a Resolution; and

WHEREAS the Borough of Council of the Borough of Abbottstown wishes to enter into an Intermunicipal Agreement with Berwick Township in order to provide emergency roadwork on Abbottstown Borough streets on an as-needed basis, a copy of the said Intermunicipal Agreement is attached hereto and made a part hereof.




