ORDINANCE NO. 2024-02

AN ORDINANCE OF THE BOROUGH OF ABBOTTSTOWN, ADAMS COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 2019-04, AS CODIFIED IN CHAPTER 197 OF THE CODE OF THE BOROUGH OF ABBOTTSTOWN RELATING TO GENERAL PARKING REGULATIONS

The Council of the Borough of Abbottstown, Adams County, Pennsylvania, enacts and ordains:

SECTION 1.

Ordinance 2019-04 is hereby amended to include:

§ 402. Parking Prohibited at all Times in Certain Locations.

- 1. The following acts shall be unlawful within the Borough as follows:
 - S. No vehicle shall be parked on any curb or place along either travel direction lanes (i.e., Eastward, Westward, Northward or Southward, as the case may be) of Sutton Road between Kinneman Road to W. Fleet Street.
 - T. No vehicle shall be parked on any curb or place along the Eastward or Westward travel direction lanes of Abbott Street from West King Street (SR 0030) to High Street.

SECTION 2.

Any Ordinance or Resolution, or any portion of any Ordinance or Resolution, of the Borough of Abbottstown, which is inconsistent with the contents of the present Ordinance shall be, and the same is hereby, repealed insofar as the same is affected by or inconsistent with the provisions of the present Ordinance.

SECTION 3.

If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed to be a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions of the present Ordinance.

SECTION 4.

The Code of the Borough of Abbottstown, as amended, shall be and remain unchanged and in full force and effect except as amended, supplemented, and modified by this Ordinance, This Ordinance shall become a part of the Code of the Borough of Abbottstown, as amended, upon enactment.

SECTION 5.

This Ordinance shall be effective immediately following its legal enactment.
